Objectives of the Program:

This 5-week program provides hands-on work experience combined with a unique cultural experience. Students will work in teams on a consulting project for a Spanish business client. The project will be defined by the client and student teams will prepare a written report and make a formal presentation to the client at the end of the program with their proposed solutions/advice and recommendations for the client. The purpose of the program is to provide students with a real-life work experience solving real business problems through teamwork in an international setting. Students will also gain valuable experience working with students in different majors, as well as gain experience developing and making presentations and preparing and writing formal business reports.

Academic Program & Requirements (6-12 Credit Hours Typical):

Courses are 3 credit hours. Expected courses offered include: Business Law (ACCT 2700), Fundamentals of Accounting (ACCT 2810), Principles of Marketing (MKTG 3100), Principles of Management (MNGT 3100), Strategic Management (MNGT 4800), and International Field Study Analysis Project (MNGT 4610). Note: Courses subject to change. Students must have completed prerequisites for course credit. See Director for course dates and format.


Program open to all business majors/minors or related fields. Students must have a 2.25 or higher GPA and must complete all requirements for credit.

General Information

Do you want to stand out from your peers when it is time to look for a job? Do you want to have an enriching international experience? Then upgrade your resume and expand your horizons consulting in Seville, Spain, this summer. Seville is the artistic, cultural, and financial capital of southern Spain.

This program offers a unique opportunity to work on a team based project. Experienced, full-time on-site staff arrange for students to work on a specific project for a company in Seville. Staff are available throughout the program for any needed translation and client interaction. The AU professor will be on site for the program duration as well.

Teams typically include 3-5 Auburn students. This program is appropriate for all business majors and minors as teams will be created to include complimentary skill sets needed to complete client projects.

The program will include excursion travel. No foreign language skills are required, but students who wish to improve their Spanish skills will have ample informal opportunities and can arrange for optional formal class/training.

Travel will include a weekend trip to Granada, a day in Cordoba, and day trip to a beach. Weekly cultural and social activities in Seville include a flamenco show, Mediterranean tasting session, Arab tea house, bike tour, and "Tapeando" culinary and social event. Tours and specific details will be provided prior to departing the U.S. and are subject to change.

Program Fees: \$8,628:

Program fees include AU coursework credit hours (6-12 typical), consulting client placement, housing in Seville for the duration of the program, full meal program, cultural and professional programs, day tours and one weekend excursion outside Seville, welcome and farewell receptions, trip cancellation insurance, and emergency evacuation insurance (does not replace major medical). Specific tour/event details provided before departure from U.S. and subject to change.

Estimated Additional Costs: \$3,238 (not included in program fees)

Estimated additional costs not included in program fees include: airfare to Seville and return, passport and visa if needed, optional tours, Auburn Abroad fee and HCoB Professional fee.

Passport and Visa Requirements:

Students are required to have a valid passport, good for 1 year after they return to the US at the end of the program.

Living Arrangements/ Housing/Meals/Transportation:

Students stay in local homes in Seville and have the choice of pairing up with another AU student or going solo. Three meals a day and weekly laundry service are included in the program fees. Client locations and the common work space are typically within walking distance of the home stay locations and in the heart of the city. Ride share bikes are located all over the city if desired for transportation. Specific housing location and details will be provided prior to departure from the U.S.
